**AND**

**IN THE MATTER** of an application by Ranjit Morar Limited for the renewal of a licence pursuant to Section 127 of the Act in respect of the premises situated at **42 The Town Centre, Turangi** and known as "**Fresh `n` Easy Supermarket**".

**THE APPLICATION**

This is an application by **Ranjit Morar Limited** for the renewal of an **Off Licence** in respect of the Licensed Premises known as **Fresh `n` Easy Supermarket**, situated at **42 The Town Centre, Turangi**.

The applicant is the holder of an **Off Licence** 20/OFF/0043/2016 which was last renewed by the Taupo District Licensing Committee on 30<sup>th</sup> of March 2016

The application was duly advertised on the Taupo District Council website from 26 November 2018 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

**REASONS FOR THE DECISION**

The applicant is a proven operator and has not come to notice in an adverse manner since the CPO failure on the 18<sup>th</sup> of December 2015. The current licensed hours are reasonable, and no changes are sought.

We are satisfied that the business is that of a grocery store and that food products is principal source of annuals sales revenue.

**THE DECISION**

Overall, we are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the refreshed conditions.

I direct that a notice of renewal and a replacement licence be issued containing a revised condition relating to the placement of non-alcoholic beer within the Single Alcohol Area.
