**IN THE MATTER** of an application by NZ Education & Tourism Corporation Limited for the renewal of an ON licence pursuant to Section 127 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 671 Wairakei Drive, Taupo and known as “**Wairakei Terraces**”

**The Application:**

This is an application by NZ Education & Tourism Corporation Limited for the renewal of an **On Licence** in respect of the licensed premises known as **Wairakei Terraces**, situated at **671 Wairakei Drive, Taupo**. It was formally received by the Taupō District Licensing Committee on 21st December 2018.

The applicant is the holder of an **On Licence** 20/ON/0120/2016 that was last issued issued by the Taupo District Licensing Committee on 21 December 2018.

The application was duly advertised on the Taupo District Council website from 8 January 2019 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

**The Reasons for the Decision:**

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

We endorse the issue raised by the Police and Inspector in that a certificated manager must be appointed to the business and on duty at all times they are open for the sale and supply of alcohol.

**The Decision:**

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupo District Licensing Committee.

### Notice of Renewal of On Licence

*Section 135, Sale and Supply of Alcohol Act 2012*

To: **NZ Education & Tourism Corporation Limited**

Licence **20/ON/0120/2019** replacing licence **20/ON/0120/2016**

The ON Licence in respect of the premises situated at 671 Wairakei Drive, Taupo known as “**Wairakei Terraces**” is renewed.

The present conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

**The licence is renewed for three years and expires on 21 December 2021.**
