The Application:

This is an application by Dominus Providebit Limited for the renewal & variation of an **On Licence** in respect of the licensed premises known as **Ploughmans Restaurant & Bar**, situated at **43 Charles Crescent, Taupo**. It was formally received by the Taupō District Licensing Committee on 17th May 2021.

The applicant is the holder of a **On Licence** [Licence Number 20/ON/0268/2018] which was last renewed by the Taupō District Licensing Committee on 6th June 2018.

The application (with variation to the trading hours) was publicly notified in the “Taupo Times” newspaper on 11 June 2021 and on 18 June 2021. There was also a notice placed on the exterior of the premises during this time. The application did not attract any objections from the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

The Reasons for the Decision:

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on revised conditions.

Notice of Renewal & Variation of On Licence

Section 135, Sale and Supply of Alcohol Act 2012

To: **Dominus Providebit Limited**

Licence **20/ON/0268/2021** replacing licence **20/ON/0268/2018**

The On Licence in respect of the premises situated at 43 Charles Crescent, Taupo known as “**Ploughmans Restaurant & Bar**” is renewed and varied.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

The licence is renewed for three years and expires on 15 May 2024.
