The Application:

This is an application by October Edwards Limited for the renewal and variation of an **On Licence** in respect of the licensed premises known as **The Fern Cafe**, situated at **11/19 Tamamutu Street, Taupo**. It was formally received by the Taupō District Licensing Committee on 15th October 2021.

The applicant is the holder of a **On Licence** [Licence Number 20/ON/0340/2020] which was first granted by the Taupō District Licensing Committee on 18 December 2020.

The application (with variation to the trading hours) was publicly notified in the “Taupo & Turangi Weekender” on 25 November 2021 and on 2 December 2021. There was also a notice placed on the exterior of the premises during this time. The application did not attract any objections from the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

The Reasons for the Decision:

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

We approve the additional hours.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on amended conditions

Notice of Renewal and Variation of On Licence

Section 135, Sale and Supply of Alcohol Act 2012

To: **October Edwards Limited**

Licence **20/ON/0340/2021** replacing licence **20/ON/0340/2020**

The On Licence in respect of the premises situated at 11/19 Tamamutu Street, Taupo known as “**The Fern Cafe**” is renewed.

The amended conditions of the licence shall apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

The licence is renewed for three years and expires on 18 December 2024.
