# The Application:

This is an application by Taupo Brewery Limited for the Variation of an **On Licence** in respect of the licensed premises known as **Crafty Trout Brewing Company**, situated at **133 Tongariro Street**, **Taupo**. It was formally received by the Taupō District Licensing Committee on 3rd December 2021.

The applicant is the holder of a **On Licence** [Licence Number 20/ON/0189/2020] which was last renewed by the Taupō District Licensing Committee on 14<sup>th</sup> May 2020.

The Inspector has provided a report that recommends that the variation sought to include a portion of the footpath outside of the premises, be granted.

However, he does recommend that the finish time for use of the area be set at 11.00pm each night to align with similar premises nearby.

# The Reasons for the Decision:

The Committee agrees with the Inspector that the variation should be granted, and we also believe the finish time should be 11.00pm as a measure of consistency with other nearby premises.

This condition can be reviewed at the 3-year renewal in April 2023.

# The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the variation of the licensed area with the expiration date of 8 April 2023 to remain unchanged.

A notice of variation and a Replacement Licence are to be issued.
