

**IN THE MATTER** of the Sale and Supply of Alcohol Act 2012 (the Act)

**IN THE MATTER** of an application by Turangi Tavern Limited for the renewal of an ON licence pursuant to Section 127 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 277 Te Rangitautahanga Road, Turangi and known as "**Turangi Tavern**"

**The Application:**

This is an application by Turangi Tavern Limited for the renewal of an **On Licence** in respect of the licensed premises known as **Turangi Tavern**, situated at **277 Te Rangitautahanga Road, Turangi**. It was formally received by the Taupō District Licensing Committee on 25th July 2022.

The applicant is the holder of a **On Licence** [Licence number: 20/ON/0293/2019] which was last renewed by the Taupō District Licensing Committee on 22<sup>nd</sup> August 2019.

The application was duly advertised on the Taupo District Council website from 26 July 2022 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

**The Reasons for the Decision:**

The applicant has come to notice in an adverse manner when Police found an intoxicated patron who was not properly managed by the staff.

By agreement additional conditions will be imposed on this renewal. Patrons must not be permitted to become intoxicated on licensed premises nor should they be permitted to enter and remain on licensed premises.

No shots are to be served after 12.00 midnight.

**The Decision:**

Subject to the above, we are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for 3 years on the amended conditions as set out on the attached replacement licence.

I direct that a notice of renewal and a replacement licence be issued.

### Notice of Renewal of On Licence

*Section 135, Sale and Supply of Alcohol Act 2012*

To: **Turangi Tavern Limited**

Licence **20/ON/0293/2022** replacing licence **20/ON/0293/2019**

The On Licence in respect of the premises situated at 277 Te Rangitautahanga Road, Turangi known as “**Turangi Tavern**” is renewed.

The amended conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

**The licence is renewed for three years and expires on 13 August 2025.**
