DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE

The Application

This is an application by **Villa Italia Limited** for an Off-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **Taupo Home & Garden Show 2019**. It was formally received by the Taupō District Licensing Committee on 14th February 2019.

Reasons for the Decision

The applicant is an experienced operator and a certificated manager will oversee the tastings and off sales of alcoholic product.

The reports of the Police and the Medical Officer of Health do not oppose this application.

The Decision

I am satisfied that the criteria of Section 142 of the Sale and Supply of Alcohol Act 2012 have been satisfactorily addressed by the applicant and the licence may issue subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:

Friday 5 April 2019; Saturday 6 April 2019 and Sunday 7 April 2019 from 10.00am to 5.00pm on each day.

2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
4. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,

- b. If so directed a copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Villa Italia Limited** is authorised to sell and supply alcohol, on the premises situated at The Great Lake Centre, 30 Tongariro Street, Taupo, and known as The Great Lake Centre, 30 Tongariro Street, Taupo for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Taupo Home & Garden Show 2019.**
