# Taupo District Licensing Committee Special Licence – On Site

Section 22 and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **The Merchant of Taupo 2007 Limited** is authorised to sell and supply alcohol, on the premises situated at 30 Tongariro Street, Taupo, and known as The Great Lake Centre, 28 Tongariro Street, Taupo for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events): **The Merchant & Scenic Cellars Wine, Craft Beer & Food Expo.** 

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

#### **Conditions:**

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:

Wednesday 21 August 2019 from 5.00pm to 9.30pm (Public Expo); and Wednesday 21 August 2019 from 9.30pm to 10.30pm (Exhibitors & staff tastings).

- 2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed at the venue.
- 4. The duty manager's must be roaming around the venue to monitor those who are sampling alcohol at all stalls, as well as monitoring intoxication levels and preventing guests from becoming intoxicated.
- 5. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence shall be displayed on the premises so as to be easily read by people attending the licensed area.

## **Duration**

This licence is only in force as specified in Condition 1.

The licensed premises known as The Merchant & Scenic Cellars Wine, Craft Beer & Food Expo situated at The Great Lake Centre, 28 Tongariro Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 5 July 2019.
