1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:

Sunday 25 October 2020 from 8.00am to 5.00pm.

- 2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed at the stall.
- 4. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,

b. A copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

The licensed premises known as the Kinloch Market situated at the Kinloch Domain, Mata Place, Kinloch, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 7 September 2020.
