DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE

The Application

This is an application by **Anna May Douglas** for an On-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **Ironman NZ and Ironman 70.3**. It was formally received by the Taupō District Licensing Committee on 4th March 2021.

Reasons for the Decision

The applicant is a responsible entity to hold a Special licence and a certificated manager will oversee the sale supply and consumption of alcohol.

The reports of the Police and the Medical Officer of Health do not oppose this application.

The Decision


I am satisfied that the criteria of Section 142 of the Sale and Supply of Alcohol Act 2012 have been satisfactorily addressed by the applicant and the licence may issue subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours: **Saturday 27 March 2021 from 11.00am to 12.00 midnight; & Saturday 11 December 2021 from 11.00am to 6.00pm.**
2. The licensed area will be designated as a Supervised Area, as identified on the plan date stamped as received by Taupo District Licensing Committee on 4 March 2021.
3. Wine is to be sold by the glass only.
4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
5. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
6. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
7. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.

8. The Licensee must display signage as follows:
- a. At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
 - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

The licensed premises known as the Ironman NZ 2021 and the Ironman 70.3, situated at the Tongariro North Domain, Tongariro Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 4 March 2021

Taupo District Licensing Committee Special Licence – On Site

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Anna May Douglas** is authorised to sell and supply alcohol, on the premises situated on, Tongariro Street, Taupo, and known as Tongariro North Domain for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events): **Ironman NZ and Ironman 70.3**.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

Conditions:

This licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours: **Saturday 27 March 2021 from 11.00am to 12.00 midnight; & Saturday 11 December 2021 from 11.00am to 6.00pm.**
2. The licensed area is designated as a Supervised Area, as identified on the plan date stamped as received by Taupo District Licensing Committee on 4 March 2021.
3. Wine is to be sold by the glass only.
4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
5. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
6. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
7. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
8. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
 - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

Duration

This licence is only in force as specified in Condition 1.
