**DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE**

**The Application**

This is an application by **Forrest Wines Limited** for an Off-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **Expo at the BDO Lake Taupo Cycle Challenge**. It was formally received by the Taupō District Licensing Committee on 4 November 2022.

**Reasons for the Decision**

The applicant is a responsible licensee, and a certificated manager will oversee the tastings and the sales for off-site consumption.

The reports of the Police and the Medical Officer of Health do not oppose this application.

**The Decision**

I am satisfied that the criteria of Section 142 of the Sale and Supply of Alcohol Act 2012 have been satisfactorily addressed by the applicant and the licence may issue subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for **consumption off the premises**, or supplied as a sample for consumption on the premises, only on the following days and hours:


**Friday 25 November 2022 from 12.00 noon to 8.00pm.**

2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
4. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,

- b. If so directed a copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area (booth number 5).

The licensed premises known as Forrest Wines situated at the Expo for the BDO Lake Taupo Cycle Challenge at The Great Lake Centre, 30 Tongariro Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 4 November 2022.

## Taupo District Licensing Committee Special Licence – Off Site

*Section 22 and 64, Sale and Supply of Alcohol Act 2012*

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **Forrest Wines Limited** is authorised to sell and supply alcohol, on the premises situated at The Great Lake Centre, 30 Tongariro Street, Taupo, and known as The Great Lake Centre Taupo Expo for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Expo at the BDO Lake Taupo Cycle Challenge**.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

### Conditions:

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:

**Friday 25 November 2022 from 12.00 noon to 8.00pm.**

2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
4. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
