## **DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE**

### **The Application**

This is an application by **Le Currents Limited** for an On-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **Le Currents**. It was formally received by the Taupō District Licensing Committee on 6th May 2022.

### **Reasons for the Decision**

The applicant appears to be a suitable entity to hold a Special licence. Certificated managers and COA security officers will oversee the sale and supply and consumption of alcohol.

The applicant has agreed to a suite of conditions with the agencies.

The reports of the Police and the Medical Officer of Health do not oppose this application.

### **The Decision**


I am satisfied that the criteria of Section 142 of the Sale and Supply of Alcohol Act 2012 have been satisfactorily addressed by the applicant and the licence may issue subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours: **Tuesday 27 December 2022 from 12.30pm to 9.00pm (the bar is to close at 8.15pm).**
2. The whole of the premises is to be designated as a Restricted area.
3. Only the following types of alcohol may be sold and in the following types of containers only: Beer, RTD's and alcoholic cider will be sold at the event, no free-pour spirits. All products will be served in cans and plastic recyclable cups.
4. "Red Bull" is not to be mixed with any alcoholic beverages.
5. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
6. Alcohol serves: A maximum of two alcoholic drinks can be sold to one person at any one time from 12.30pm to 8.15pm.

7. A certificated must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
8. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
9. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
10. Police request the ability to require further reduction of alcohol service sizes, or a shift to low alcohol beverages, or to request a closure of all, or any bar, at any time based on intoxication levels and/or crowd behaviour. Any request will be evidence based on review meetings with the licensee and any of the Police, Taupo Licensing Inspectorate, or the Medical Officer of Health Representative.
11. Police request that the "Alcohol Leadership Team" are not under any circumstances to personally serve or sell alcohol at any stage, with the premise being that they are there to supervise the two bars at the event.
12. The Licensee must display signage as follows:
  - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
  - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

The licensed premises known as the Le Currents 2022 situated at Riverside Park, Redoubt Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 6 May 2022.

## Taupo District Licensing Committee Special Licence – On Site

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Le Currents Limited** is authorised to sell and supply alcohol, on the premises situated at Riverside Park, Redoubt Street, Taupo, and known as Riverside Park, Taupo for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events): **Le Currents**.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

### Conditions:

This licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours: **Tuesday 27 December 2022 from 12.30pm to 9.00pm (the bar is to close at 8.15pm).**
2. The whole of the premises is to be designated as a Restricted area.
3. Only the following types of alcohol may be sold and in the following types of containers only: Beer, RTD's and alcoholic cider will be sold at the event, no free-pour spirits. All products will be served in cans and plastic recyclable cups.
4. "Red Bull" is not to be mixed with any alcoholic beverages.
5. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
6. Alcohol serves: A maximum of two alcoholic drinks can be sold to one person at any one time from 12.30pm to 8.15pm.
7. A certificated must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
8. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
9. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
10. Police request the ability to require further reduction of alcohol service sizes, or a shift to low alcohol beverages, or to request a closure of all, or any bar, at any time based on intoxication levels and/or crowd behaviour. Any request will be evidence based on review meetings with the licensee and any of the Police, Taupo Licensing Inspectorate, or the Medical Officer of Health Representative.
11. Police request that the "Alcohol Leadership Team" are not under any circumstances to personally serve or sell alcohol at any stage, with the premise being that they are there to supervise the two bars at the event.
12. The Licensee must display signage as follows:
  - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
  - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

### Duration

This licence is only in force as specified in Condition 1.
