## On Site Special Licence

*Section 22 and 64, Sale and Supply of Alcohol Act 2012*

Pursuant to the Sale and Supply of Alcohol Act 2012, **Phoenix Rugby League Taupo Incorporated** is authorised to sell and supply alcohol, on the premises situated at 3 AC Baths Avenue, Taupo, and known as Phoenix Rugby League Club Taupo for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events): **Phoenix Rugby League Taupo - Game Day Hosting.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

### CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:  
**Saturday 5 August 2023 from 4.00pm to 11.30pm.**
2. **No gang clothing or memorabilia is permitted to be worn in the licensed premises or the surrounding playing fields.**
3. The clubrooms and the deck area of the clubrooms as per the floor plan supplied with the application, is designated as a supervised area
4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
5. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
6. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard
7. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages
8. The Licensee must display signage as follows:
  - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
  - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

### THE LICENSED PREMISES

The licensed premises known as "Phoenix Rugby League Club Taupo" situated at 3 AC Baths Avenue, Taupo, , is more precisely identified as outlined in the Event Site Plan provided with the application, as received by the Taupo District Licensing Committee on 20th July 2023.

# THE LAW

## Intoxication

Intoxicated people are not permitted on licensed premises. It is an offence to allow persons to become intoxicated here. It is an offence to serve an intoxicated person.

**Intoxicated people will be required to leave.**

## Minors

A current NZ driver's licence, passport, Hospitality NZ 18+ card, or Kiwi Access card are the only types of ID that we can accept.

**If you look under 25, you may need to prove your age.**
