The Application

This is an application by Begin Distilling Limited for an off site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the Taupo Home and Garden Show 2024. It was formally received by the Taupō District Licensing Committee on 1st March 2024.

Reasons for the Decision

The applicant appears to be a responsible entity to hold a Special Licence and a certificated manager will oversee the sale, supply and consumption of alcohol. **Up to 1500 persons are expected to attend the Home & Garden Show**

The Police and Medical Officer of Health reports raise no matters in opposition.

By agreement a suite of agreed discretionary conditions will apply.

The Decision

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant a Special Licence authorising the sale and supply of alcohol to any person attending the following occasion or event (or series of occasions or events): Taupo Home and Garden Show 2024.

The licence shall be subjected to mandatory and discretionary conditions as detailed in the attached licence.

Off Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Begin Distilling Limited** is authorised to sell and supply alcohol, on the premises situated at **5 Story Place, Taupo and known as The Great Lake Centre**, for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Taupo Home and Garden Show 2024**.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:
Friday 12 April 2024 from 10.00am to 5.00pm; Saturday 13 April 2024 from 10.00am to 5.00pm; & Sunday 14 April 2024 from 10.00am to 4.00pm.
2. Tasting samples of up to 5ml of alcoholic spirit (with a mixer) in tasting cups will be provided, and patrons are only permitted to taste a maximum of three samples each.
3. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stand (number 232).
5. The Licensee must display:
 - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,

DURATION

This licence is only in force as specified in Condition 1.

THE LICENSED PREMISES

The licensed premises known as Juno Gin situated at stand number 232 at The Great Lake Centre, 5 Story Place, Taupo, is more precisely identified as outlined in the "Taupo Home & Garden Show 2024 Site Plan" provided with the application, as received by the Taupo District Licensing Committee on 1 March 2024.
