DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE

The Application

This is an application by Dean Richard Fleming for an off site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the Spa Road Farmers Market. It was formally received by the Taupō District Licensing Committee on 13th March 2024.

Reasons for the Decision

The Police and Medical Officer of Health reports raise no matters in opposition.

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant a Special Licence authorising the sale and supply of alcohol to any person attending the following occasion or event (or series of occasions or events): Spa Road Farmers Market.

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours: **Saturday 6 April 2024 from 9.00am to 1.00pm; and Saturday 4 May 2024 from 9.00am to 1.00pm.**
2. Only 700ml size sealed glass bottles are to be sold for off-site consumption, and No tastings are to be done.
3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
4. The Licensee must display:
 - a. At every point-of-sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

The licence shall be subjected to mandatory and discretionary conditions as detailed in the attached licence.

Off Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Dean Richard Fleming** is authorised to sell and supply alcohol, on the premises situated at Spa Road Farmers Market, Spa Road Venture Centre, Taupo, and known as Spa Rd Farmers Market, Spa Rd Venture Centre, Spa Rd, Taupo for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Spa Road Farmers Market**.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours: **Saturday 6 April 2024 from 9.00am to 1.00pm; and Saturday 4 May 2024 from 9.00am to 1.00pm.**
2. Only 700ml size sealed glass bottles are to be sold for off-site consumption, and No tastings are to be done.
3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
4. The Licensee must display:
 - A. At every point-of-sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - B. A copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

DURATION

This licence is only in force as specified in Condition 1.
