IN THE MATTER of an application by Two Brothers Hospitality Limited pursuant to Section 136(1) of the Sale and Supply of Alcohol Act 2012 for a Temporary Authority in respect of the premises situated at 4600 State Highway One, Turangi and known as "Turangi Bridge Motel".

This is an application by Two Brothers Hospitality Limited for a Temporary Authority for a premises situated at 4600 State Highway One, Turangi to be known as Turangi Bridge Motel.

There is a substantive Temporary Authority in place with the licence number 20/ON/0281/2022 that expires on 15th of February 2025.

The application contains supporting documentary evidence indicating that a sale and purchase agreement have been completed for the business.

Accordingly, the application is to be dealt with by the committee on the papers.

REASONS FOR THE DECISION

Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the granting of the order.

THE DECISION


The application and supporting information satisfy us that the criteria we must have regard to as set out in s.136 of the Act has been met.

Section 136(5) of the Act says the person authorised by the order has for the purposes of this Act the same duties, obligations, and liabilities as the holder of the on-licence concerned.

The District Licensing Committee, acting pursuant to the Sale and Supply of Alcohol Act 2012 makes an order for a Temporary Authority ON Licence with the existing conditions on the base licence continuing to apply:

- **The Order is to run for 3 months from the 20h of March 2024;**

Temporary Authority

Section 136(1) of the Sale and Supply of Alcohol Act 2012

Pursuant to Section 136(1) of the Sale and Supply of Alcohol Act 2012 the Taupo District Council in its capacity as District Licensing Committee has made an order authorising **Two Brothers Hospitality Limited** to carry on the sale and supply of alcohol for consumption on the premises known as **Turangi Bridge Motel**, situated at, **4600 State Highway One, Turangi**.

This Temporary Authority shall be in force from **20 March 2024** until the substantive licence application lodged by **Two Brothers Hospitality Limited** is determined, or until **20 June 2024**, whichever is the sooner.

This Temporary Authority is issued subject to the following conditions:

- The order is to run for 3 months from the 20 March 2024

The person authorised by this order, has for the purposes of this Act, the same duties, obligations, and liabilities as the holder of the on licence concerned.
